Discussion item: WP1, DEV1.2:

Minutes from last PMB meeting were adopted.

Prof. Dr. Danilo Nikolić (UoM) started with the status of the GAP analysis document. He showed the questionnaires that were distributed to the UV and AMUD.

Prof. Dr. Srdjan Redzepagic (UCA_F) expressed the satisfaction with the document and the whole progress and results. General coordination of different tasks are well done.

Prof. Dr. Osman Metalla (AMUD) said that we worked together and the success of the project activities are expected. Other members had no comments.

Finally, PMB members voted and adopted the report DEV1.2.

Discussion item: WP1, DEV1.3:

Prof. Nikolić stated that trilateral meeting in Kotor will be organized between UV, AMUD, and UoM. Proposed curricula will be discussed. He went through the suggested courses in the application form. 
