Lines of the meeting

University of Cadiz settled up the topics for the first training (DEV3.4.1):

- Marine Pollution generated by shipping industry: UE legal instruments to reduce and prevent it,
- Environmental Sensitivity Maps: a tool to limit beach oiling pollution,
- Land and shipping-based effluents as sources of marine pollution: Technologies for its minimization.

The dates for two of the training sessions by UCA_S are planned for the following weeks: 21-27 June; 28 June - 4 July.

Explanation: It will be conducted entirely in *online* format. UCA_S will hold two training sessions in June and one training in the second half of September 2021. The UCA_F, in principle, will hold its three training sessions in June 2021. Specific dates may be agreed for each teacher/session/topicz.

- On in-vivo training (in general): all sessions of all teachers (UCA_S and UCA_F) have to be concentrated on two days (agreed in advance).

About the sessions: each teacher's session on each topic will last a minimum of two hours.

- UCA_S will be sending to UCA_F the topics for DEV3.4.1 and the possible dates.
- UCA_S will send a doodle next Monday to the coordinators to set the dates for the two UCA_S trainings in June. The UCA_F will be able to use these dates or choose other dates for their training.

About DEV 1.1:

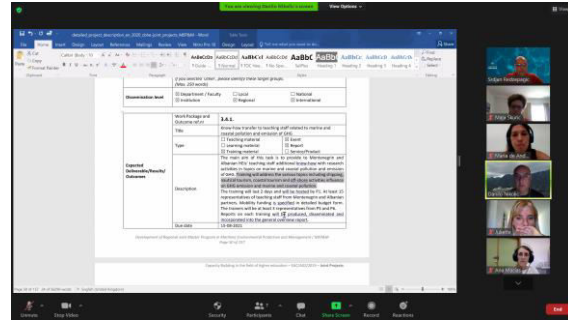
- UCA_S will send the links of the masters' websites to the coordinator and UCA_F.
