Afterwards, the working team visited the laboratories of the Faculty of Maritime Studies Kotor.

It was concluded that both institutions will continue with the promotion and dissemination events within the project in order to prepare the platform for the joint master program full introduction to the audience. In addition, partners agreed to expand cooperation with joint application for EU funded projects.




