**Discussion items and conclusion**

As a part of the Erasmus + project entitled “Development of Regional Joint Master Program in Maritime Environmental Protection and Management (MEP&M)”, a working meeting was held with the representatives of the Faculty of Maritime Studies Kotor of the University of Montenegro on Tuesday (July 20th, 2021) at the premises of the Agency for Control and Quality Assurance of Higher Education in Podgorica, Montenegro. The Agency is in charge of program accreditations in Montenegro.

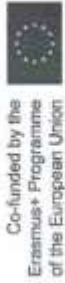
The meeting was organized regarding the accreditation of a joint regional master program MEP&M in English. On that occasion, one of the main issues of the accreditation process itself was discussed - that is the legislative framework of domestic and foreign higher education institutions.

The Agency’s representatives presented directions in accreditation of such program. It was concluded that the procedure of accreditation of such a program in English implies a similar procedure for accreditation of the standard master study program on foreign language following the *Rulebook on the procedure of accreditation of study programs, content, and form of the accreditation certificate*.

Additional conclusion was that the standards must be met for the evaluation of the study program, about which more information will be in the implementation of the MEP&M project.
